11.	Information:
11.1	The council would look again at trying to get the speed limits reduced within the parish.
11.2	The Moat Management are filling the lake up again after the de-silting. They are holding a tea party on 8 <sup>th</sup> July.
11.3	The char 1 developer is a company owned by A.B.C a condition to build the houses is that 64% are 2-3 bedrooms and the rest will be 4 bedroom properties.
11.4	Wheler North:The water study carried out will be sent to the planning committee . Two accesses off the A20 will not work. The council need to sort out S106 requirements on Parking, New hall, Refurbishment of the public toilets, a natural cemetery, and an all-weather footpath from Charing Heath to Charing, Disabled lift at the railway station. Grants could be obtained to help with cost of the lifts.
11.5	Over 2 million pounds has been given to KCC for road improvements from Charing roundabout to Chilham.
11.6	Tatinger are developing a wine area centre at Chilham in conjunction with the vineyards in the area.
11.7	The new name for the Green Health Club has been put forward as Harrisons Court, this could confuse people as we have Harrison used in the parish already. Councillors will think on other suitable names that could be put forward.
11.8	It has been reported that asbestos has possibly been buried on land owned by Charing Meats. It has been reported to the appropriate authorities.
