	ABC Properties gave a presentation. They aim to build a portfolio of about 400-500 private rented
	properties, partly in order to fund money back to ABC. Char 1 houses will, however not be rented but sold
	in order to help build the rental portfolio.
	Given the need for smaller houses in Charing, and also in order to build something in character with the
	village, they are proposing 10 x 2 Bed Flats; 11 x 2 Bed Houses; 30 x 3 Bed Houses; 9 x 4 Bed Houses rather
	than the proposals in the outline application. Designs were shown as to how they envisaged the houses looking. There was general agreement that the
	style looked appropriate. Amendments were suggested to the mix so that it included some three bed flats
	that were fully accessible and also some one bed units. Councillors also asked for indicative prices.

9.1	Approval of Budget. S Crawley reported that if the CPC increased the precept by 22% overall it would
	cover the costs of CCTV.A large majority of parishioners have indicated they would be prepared to see an

increase in their Council Tax to facilitate this. S Crawley explained that it would be a one off increase not leading to a permanent increase of the same amount. She also explained that it works out to be a one off amount of between £8.30 - £12.15 per household depending on Council Tax Banding for the year. Councillors in favour put forward that CPC increase this by a further 3% to make 25% which would cover costs for CCTV and other issues.
