7.6	Village Confines: A consultation was carried out in January on proposed confines for Charing and			
	Charing Heath. A clear majority supported the proposed confines for Charing. In the light of some			
	comments made during the survey a few very minor changes to exclude undeveloped areas on the			

periphery were agreed by the Council.

In Charing Heath the consultation had presented two options. There was a small majority in favour of the more limited option. Two suggestions for change had been received. One concerned an extension to a parcel of land along Church Hill – a rather smaller extension was agreed. The other proposed a much larger area for the confines – this was considered inappropriate.

A member of the public present suggested that the confines were unfair in that some residents would be able to develop their land but others not; however the unfairness was due to the change to ABC's policy that the Planning Inspectorate had imposed. It was pointed out that allocations outside the confines can be made under the Neighbourhood Plan.
