- 5. To accept the following Policies
- **5.1.** Standing Orders: All councillors read and accepted the policy.
- **5.2.** Code of Conduct: All councillors read and accepted the policy.

- 6. Matters Arising:
- **6.1. Brockton Farm**: Ancient hedging has been removed and three new gateways have been installed plus two new entrances. ABC enforcement team are aware. If correspondence is sent, then ABC cannot contact the residents for a month. All documentation is being gone through in fine detail. WE will contact ClIr Bell & ClIr Clarkson.
- **Public Toilets:** With new rules on the opening of the public toilets we may have to block off the urinals. Other measures will have to be enforced. A risk assessment will be carried out by the clerk to see if and when the re-opening is safe to employees and users.
- **6.3 Land South of the Swan Charing update:** A meeting is to be held with Simon Cole, Cllrs Leyland, Gudge and a couple of residents from Poppyfields. Residents will also have a separate meeting with planning. There is concern over the current sewerage system and if it can cope with the additional housing. Who would be responsible for the sewers?
- **Sundial Garden:** The council have been asked if the snake that is rapidly growing in the Sundial garden can be a permanent feature. The council agreed that this is a good idea to make it a permanent feature to remember Covid-19 and how residents expressed lockdown. This would be a permanent piece of history. The snake would be required to be set in concrete. Our insurance company has said that in its present state we could not have it in a straight line as it would be a trip hazard with it crossing pathways. It could be coiled in some way. Once the final decisions have been made the clerk will double check that our insurance company are happy.
- **CCTV:** The clerk will contact the church warden re siting the appropriate equipment on top of the church. The committee should have met or be meeting soon. We the increase in vandalism we need to start getting the CCTV installed.
