Chair's Report

Writing this newsletter in early May and looking back on the last communication some things have changed especially with Maidstone Borough Council's (MBC) acceptance of the Heathlands project which will see approximately 5000 houses being built right on our doorstep. This move also threatens the closure of Lenham and Charing railway stations with a new station being built at Heathlands. Couple this with a call for sites from Ashford Borough Council (ABC) for the next phase of their local plan from 2030 onwards, it is clear to us that there is a distinct possibility of a ribbon development from Charing through to Lenham, just like Lenham to Harrietsham. We are already working with Lenham Parish Council in trying to thwart this development. As of this moment there could be a change of power within MBC where it might reject this proposal outright. Watch this space......

Development throughout the parish is still on hold due to the Stodmarsh SSI becoming contaminated with leachates that run of from the surrounding land that feeds into the Stour, no solution, mitigating circumstances or exemptions have been approved so far, the relevant councillor's, who have been doing a sterling job, are remaining vigilant with the emerging policies.

As reported earlier Charing Heath has suffered and is still suffering from a plethora of breaches to the planning system with one that has been going on for at least 20 years. During this time ABC has had ample opportunities to end this woeful situation. The CPC will continue to make strong representations to the planning officers to support the Parish Council in bringing these breaches to a satisfactory conclusion.

The council have been exploring the possibility of holding Council meetings, possibly 2-3 times per year to broaden the contact between Charing Heath and the Council. We will also be arranging an informal surgery during the coming weeks that will be advertising the date and venue on our web site, Social media and notice boards. So please keep an eye out.

The parish council now has a full complement of councillors, which is great news for the parish.

.Highways Working Group (HWG) (Sub committee of CPC)

We have a number of small improvements we want to make in the parish. Progress, however, is not fast as KCC Highways will only work on a maximum of two projects per parish at any one time and dealing with the bureaucracy is not a quick process. Finance is also a constraint since the Parish Council has to find most, if not all, of the



cost of any improvements. £10,600 has been allowed in the current year's budget for this. Finally, we have to pick projects which Highways will support – these will not always be the ones we consider highest priority.

Currently we are working on two projects. The first is extending the 40mph limit in Faversham Road; currently this only covers the stretch from the junction with the A252 at the top of Charing Hill to just beyond the junction with Stalisfield Road. This will now be extended to just beyond the Wagon and Horses. We had hoped to take it to right up to the parish boundary but there are not enough houses on the road for Highways to support this. While disappointed, we still feel it is worth doing as it will cover an area where there have been a number of accidents. The Parish Council will have to cover the cost of the Traffic Regulation Order (£3,000) and the cost of the signs and their installation but we are grateful to our KCC Councillor, Charlie Simkins, for covering the £1,124 design cost.

The Faversham Road scheme looks likely to take up much of our budget this year. The next scheme is one which can be done piecemeal as finance allows. You will doubtless have noticed that a number of villages in Kent have white "gates" at the point of entry. When properly situated these can make it clearer to drivers that they are about to enter a village. Often they can be combined with the village nameplate and possibly the speed limit sign. We have agreed two sites for such gates with KCC. One is on the A252 as you approach the junction with Faversham Road and will be on the left opposite the refuge in the middle of the road. The second will be a pair of gates on the A20 as you approach from Ashford and will be at the 40mph sign. It will incorporate a village nameplate with the current one, way too far out of the village, being removed. (We have not yet been able to agree a site for the approach from Maidstone with Highways.)

We had hoped to have gates on Pluckley Road too, where there is a major problem with many vehicles exceeding the speed limit, but there is no suitable place with a wide enough verge which will not interfere with sightlines for someone exiting their house. Instead, Highways have suggested a smaller design which will incorporate the village nameplate, again with the existing nameplate, which is just by the motorway bridge, being removed. We had also hoped to have "roundles" in the road to remind people of the speed limit but these are not legal in a 30mph limit where there are lampposts. Informal signs are, however, possible on residents' land and we are pursuing this. Since much of the speeding on Pluckley Road is, we believe, inadvertent we have selected this as a sign which could be put on grass verges etc. We will be discussing this with residents shortly.

Many will have noticed that the "Vehicle Activated Sign" which was on the A20 approaching from Ashford, and flashed up with a 40mph reminder if you exceeded the speed limit, has disappeared. Sadly, it had stopped working and was not capable of repair. It had been installed in 2006 and had lasted well beyond its design life of 6 years. If we want it replaced we will have to pay for it and, in any case, changes in road conditions mean we would need to make a new case for it.

KCC is currently reviewing the changes made to the crossroads of the A20 with Station Road and the High Street. We have passed on our concerns including the number of vehicles turning right or going straight on from Station Road and the need to improve signage.



Finally some local residents are hoping to resurrect speedwatch. If you are interested in taking part please contact the clerk. And check out the Highways Page on the parish council website for further updates on all the issues mentioned above. **Jill Leyland / Colin Burns**

We will also be arranging an informal surgery during the coming weeks where residents can speak to their Charing Heath councillors. These will be held on a Saturday morning in Charing Heath.


We will be advertising the date and venue on our web site, Social media and notice boards. So please keep an eye out.

Charing in Bloom

Phase one of the CCTV project is now up and running. This includes the first three cameras which are monitored 24/7 by the monitoring unit within Ashford Borough Council.

The cameras are fully ANPR compliant, Infrared for night time operation and can be used in real time for any anti social behaviour or for historical investigation.

More cameras will come online shortly once the necessary permissions have been agreed by Kent County Council Highways.
