3.	To receive any declarations of interest from Members.  Members are invited to declare disclosable pecuniary interests and other interests in items on the agenda as required by Charing Parish Council Code of Conduct for Members and by the localism Act 2011.			
4.	Public Participation Session This provides an opportunity for members of the public to raise questions about and comment on items on the agenda. Time for this session is limited to 10 minutes (divided by the number of participants) Two members of public in attendance.			
5.	Reconnecting our ancient woodland (Terry Thompson) Mr Thompson explained the work that was being carried out by the organisation in protecting woodland areas and animals in particular the decline in Adders and other wild animals. Replanting and Rewilding is taking place in areas and Highways are looking at introducing a Highway Protection Areas throughout Kent.
