Chair's Report

Writing this newsletter in early September with the rain beating down it seems a far cry from summer which I hope you all enjoyed.

During the last few months, the Parish Council have had meetings with Matthew Scott Kent Police and Crime Commissioner where we discussed local issues including the unlawful use of catapults antisocial behaviour within the parish and he assured us that they were endeavouring to stamp these types of problems out. There will be a dedicated local officer appointed to the parish shortly so that we have a direct contact number. The constable will attend several parish council meetings over the year where we hope to pass on any concerns the parishioners have highlighted.

Also, our local MP Katie Lam paid us a visit and several points were discussed including the A20 junction with Station Road as the solution from Kent Highways doesn't fit the bill as people ignore the turn left only signs.

A second meeting with Katie was a joint Westwell, Sandyhurst Lane residents' association and ourselves with reference to the motorway noise. Katie is now on the transport committee at Westminster and has promised to delve into the noise issue again for us all, but lack of money will probably be the answer.

The position may have changed with the housing developments that have been on hold for some considerable time may be able to mitigate their impact on the environment by exchanging environmental credits with other developments that have an excess of environmental criteria, this is a scheme that is being run with ABC in conjunction with Canterbury City Council.

A polite reminder that **ALL** the cameras in and around Charing are now active.

My thanks go to Dawne Austen for keeping us up to date with current goings on within ABC and financially to Jo Munro who keeps us on the straight and narrow and always in credit. Also my CPC colleagues for all their work and input it's great to work with you all.

Finance Report

We are pleased to report that a grant for £26,000 was secured to facilitate the installation and ongoing maintenance of the Covid Snake in Clewards Meadow, this work has started and should be finished by the end of September.

A refund was granted to CPC for CCTV maintenance that was not carried out due to the delay in getting the CCTV system up and running. The system is now fully working and monitoring is being undertaken.

We are waiting to see what the outcome of the governments "Devolution" plans will mean to parish councils, there are differing theories as to the cost savings or otherwise that may be realised, but we can only wait and see. It may be that CPC has to purchase ex County or Borough council assets as they will no longer be part of the new authorities.

We hope to have some more detailed answers for you later in the year and we shall bring these to you as soon as we can.

We have replaced the councillors' computers as they were coming to the end of their time and the new ones should last for the next 5 years or so. Unfortunately, grants were not available to fund this but we had put aside monies in the budgets to pay for them.

Highways

The extension of the 40 mph limit in Faversham Road to the Wagon and Horses was installed at the end of June.

Many thanks to those who replied to the informal survey on painting double yellow lines on the High Street at the junction with the A20. There was strong support for the double yellows from most respondents coupled with some concern over the impact of effectively reducing parking on the shops, particularly Charing Stores. All comments have been forwarded to KCC with names removed. In due course there will be a formal Traffic Regulation Order (TRO) proposed which will give everyone a chance to express their views again.

We are also hoping that the TRO will be combined with one for the top end of The Hill. Parking on the pavement side of the Hill forces traffic travelling uphill into the opposite carriageway. When that parking is close to the junction there is a risk of collision with traffic turning into The Hill from the A252. There will be a stretch of double yellow lines opposite the entrance to the new development behind Millgarth to enable the bin lorry and other large vehicles to enter and exit but if those are installed on their own it will leave a gap just where parking is most undesirable.

KCC have promised to install signs on Stonestile Road indicating that it is unsuitable for HGVs. We do not know when.

The Parish Council is commissioning some new traffic surveys. Surveys were last done four years ago in 2021. So at some point in the Autumn - during school term times - you may notice pneumatic tubes appearing in a number of places in the Parish. These surveys give us data about speeds and traffic volumes not just informing us but enabling better discussion and negotiation with KCC Highways. They are also helpful in assessing planning applications. If you notice the tubes please drive exactly as you would normally, resisting any temptation to go faster or slower than your usual speed or to make additional or fewer journeys.

Is Heathlands a 'done deal'?

It's probably the most frequently asked question of us and the simple answer is ABSOLUTELY NOT!

The clever marketing and PR that is going on - at taxpayers' expense - is to create a perception to local people that this massive development is going ahead whether we like it or not.

Do not fall into the trap of Maidstone Borough Council.

The amount of flaws in the project mean it will be very hard, if at all, to actually deliver it. Here's 7 (of many) reasons why Heathlands is not a done deal:

- (1) Major landowners are still not signed up after over 6 years of trying. We know from one of the largest that they are simply not interested in signing up. Without land there is no 'new town'. Simple as that.
- (2) MBC and Homes England won't admit it to you but we have heard it on good authority from a source at Network Rail that they will not entertain a new rail station in the development for all the reasons SOHL have pointed out to MBC over the last few years.
- (3) Major objectors include the likes of Campaign for the Protection of Rural England (CPRE). Do not underestimate the influence these types of organisations have, despite what MBC may claim.
- (4) Lenham falls within the Stodmarsh catchment area where a moratorium is currently in place restricting all new development without sufficient nutrient neutrality mitigation. Heathlands still can not demonstrate acceptable mitigation for protecting watercourses from pollution.
- (5) There will be no motorway junction. Without a new junction the A20 simply can not cope with the additional volumes. It's simple maths. We've seen what happens with increased flows every time the M20 closes. No upgrade of the A20 can cope with such huge volumes. No proper highway modelling has been undertaken to date to truly understand the impact act of Heathlands.
- (6) The financial viability of the Heathlands proposal is questionable and has major omissions which would quickly render the project unviable. MBC and Homes England are intentionally manipulating the figures to make it look more viable than it is.
- (7) Finally, PEOPLE POWER does work, believe it or not. We've got to remain resolute in our opposition to this proposal. MBC will be wanting there to be splits in our community. Don't let them divide us!



Latest update on Local Government Reorganisation from Ashford Borough Council

At yesterday's Kent Council Leaders meeting, Leaders and Chief Executives were asked to consider which options our strategic partner KPMG should proceed working up full business cases for ahead of submitting them to Government later this year. Following a detailed discussion Kent's Leaders asked them to look in more detail at two options for the number of unitary councils needed and the areas they should cover. They are:

- 1. Three unitary councils consisting of Dartford, Gravesham, Medway and Swale in the north; Sevenoaks, Tonbridge and Malling, Maidstone and Tunbridge Wells in the west and Ashford, Canterbury, Thanet, Dover and Folkestone and Hythe in the east (upper left image overleaf).
- 2. Four unitary councils consisting of Dartford, Gravesham and Medway in the north; Sevenoaks, Tonbridge and Malling, Maidstone and Tunbridge Wells in the west; Ashford, Swale, Maidstone and Folkestone and Hythe in the middle of Kent and Canterbury, Thanet and Dover in the east (lower right image overleaf)

Individual councils can also choose to commission and submit business plans for other options.

Once KPMG and council officers have worked together to draw up business cases for each of the options, each council will go through its own decision-making process to decide which option it supports. Business plans need to be submitted to the Ministry of Housing, Communities and Local Government by 28 November and the final decision rests with ministers.

Stakeholder and public engagement

There is a clear expectation that we need to engage with stakeholders and the public in the development of the LGR business case by the government. Kent's leaders have also expressed a desire to engage with the public. MHCLG state the extent of that engagement is down to councils to determine.

The 'Change is coming' awareness raising campaign launched last month. Next week letters will be sent to stakeholders providing them with more details on the process and a survey for residents will be launched. Its contents are based on best practice from other areas that have been through LGR, input from the cross-Kent comms group and feedback from chiefs and leaders.

It deliberately doesn't ask for views on the various geographies, but centres around the principles the public might think are important considerations to help inform the business case. It is important to note this is not designed to be extensive public consultation that reaches a large number of people, but rather early engagement to shape this stage of the process. It is envisaged that more comprehensive consultation will be undertaken later in the process when there is clarity about the new unitaries and when we are looking at more detail on how they will operate.
